**Voltphreaks VPR-P6 lithium battery worth nearly \$2000.** This is a state of the art 6 pound battery that replaces an Odyssey PC680. Besides the weight difference, battery has 1200 Cranking Amps (can start almost any car), and will last much longer than most batteries of comparable size in terms of runtime when the car's alternator dies, etc. Battery has a built in remote disconnect switch, and over-charge/over-discharge protection. Voltphreaks batteries are currently used by LeMans, NASCAR, drag, rally, and other racers.
- Eligibility  
Every class is eligible!
- Winner  
Team that completes the most laps with a single vehicle while displaying a Voltphreaks decal on their vehicle who also submits the required contingency form will be declared the winner. This means you do not have to be first overall! For example if you finish 10th, but 1st through 9th place either do not have the Voltphreaks decal or do not turn in a contingency form, you will win simply by submitting the form and meeting the requirements! (Ties for number of completed laps will be decided by finishing position.)
- Requirements  
Must have a Voltphreaks decal on race vehicle while on track. Decals are provided in your registratin packet. Mail in the completed contingency form below. Remember, the car that runs the most laps that **ALSO** has submitted the form and met all requirements will win, so even if you finish 6th, 10th, 17th overall, turn in the form! All received forms **MUST** be postmarked no later than Dec. 31st, 2009.
